**FINAL JUDGMENT**

This Court having entered a default on October 8, 2009 against Defendants Wu Liang Ye Lexington Restaurant, Inc., Wu Liang Ye 86 Restaurant, Inc., Wu Liang Ye U.S.A., Inc. (collectively, the "Corporate Defendants"), Jian Li (a.k.a. James Li), and Susan Li (a.k.a. Su Xue Li, a.k.a. So Suet Li) (together with Corporate Defendants, the "Defendants"), and for the reasons stated in this Court's Order dated December 9, 2009 and in this Court's Memorandum Decision and Order dated September 30, 2010, the plaintiffs having submitted a proposed final judgment and the defendants having failed to object thereto, it is

ORDERED, ADJUDGED, AND DECREED that:

DAMAGES

1. Plaintiff Jin Ming Cao recovers jointly and severally from Defendants the sum of \$142,812.05.

2. Plaintiff Shan Xian Chen recovers jointly and severally from Defendants the sum of \$37,568.24.

3. Plaintiff Shi Hua Chen recovers jointly and severally from Defendants the sum of \$38,508.43.

4. Plaintiff Teng Yu Chen recovers jointly and severally from Defendants the sum of \$57,979.12.

5. Plaintiff Yun Hui Chun recovers jointly and severally from Defendants the sum of \$28,716.34.

6. Plaintiff Yi Lin Dong recovers jointly and severally from Corporate Defendants and Defendant Jian Li the sum of \$42,852.79.

7. Plaintiff Min Gwee recovers jointly and severally from Defendants the sum of \$297,495.85, except that the amount recoverable from Defendant Susan Li is limited to \$268,840.25.

8. Plaintiff Zeng Xiang Huang recovers jointly and severally from Defendants the sum of \$20,621.64.

9. Plaintiff Qing Lin Jiang recovers jointly and severally from Corporate Defendants and Defendant Jian Li, the sum of \$67,903.18.

10. Plaintiff Lei Li recovers jointly and severally from Defendants the sum of \$28,119.03.

11. Plaintiff Li Feng Li recovers jointly and severally from Defendants the sum of \$102,318.57, except that the amount recoverable from Defendant Susan Li is limited to \$91,461.10.

12. Plaintiff Tang Xiang Li recovers jointly and severally from Defendants the sum of \$11,205.05.

13. Plaintiff Quan Li recovers jointly and severally from Defendants the sum of \$65,952.21.

14. Plaintiff Yi Lin recovers jointly and severally from Corporate Defendants and Defendant Jian Li the sum of \$57,187.15.

15. Plaintiff Yong Quan Lin recovers jointly and severally from Defendants the sum of \$66,124.16.

16. Plaintiff Guo Hua Liu recovers jointly and severally from Corporate Defendants and Defendant Jian Li the sum of \$54,510.81.

17. Plaintiff Guo Xian Liu recovers jointly and severally from Defendants the sum of \$55,225.98, except that the amount recoverable from Defendant Susan Li is limited to \$44,791.88.

18. Plaintiff Guo Yong Liu recovers jointly and severally from Corporate Defendants and Defendant Jian Li the sum of \$61,612.66.

19. Plaintiff Guo Xing Wang recovers jointly and severally from Corporate Defendants and Defendant Jian Li, the sum of \$33,517.90.

20. Plaintiff Yi Pin Wang recovers jointly and severally from Defendants the sum of \$75,169.67, except that the amount recoverable from Defendant Susan Li is limited to \$43,037.31.

21. Plaintiff Qi Weng recovers jointly and severally from Defendants the sum of \$54,820.51.

22. Plaintiff Zhen Jian Weng recovers jointly and severally from Defendants the sum of \$73,912.52.

23. Plaintiff Wen Zhang Zhang recovers jointly and severally from Defendants the sum of \$31,509.79.

24. Plaintiff Xian Hua Zhuang recovers jointly and severally from Defendants the sum of \$80,993.18.


ATTORNEYS' FEES AND COSTS

25. Plaintiffs recover jointly and severally from Defendants the sum of \$341,329.08 for attorneys' fees and costs, which is to be calculated as follows:

- a. \$327,480.00 in attorneys' fees for the services provided by Davis Polk & Wardwell LLP ("Davis Polk");
- b. \$6,184.08 for costs incurred by Davis Polk related to court filings, transcription services, and interpreter/translator fees; and
- c. \$7,665.00 in attorney's fees for the services provided by the Asian American Legal Defense and Education Fund

26. The claims of plaintiffs Geng D. Weng and Quan Z. Li are dismissed for failure to prosecute. The Clerk of the Court shall close this case.
