

I got on the radio & asked him if he was okay & he didn't respond. I came in from the east side of the facility. I heard Robert I saw 2 employees on the center belt digging, so began to help dig up <u>_____</u> were the employees who were digging. I asked what was going on & they said, "I don't know where Robert is." To put the conveyor in reverse, you have to go the main control which is about 10 feet away. We couldn't put it in reverse because the material on the belt was too heavy. I have on-going training on the belt</u></p>

Walking the belt is hand sorting the contaminants in a material. We have employees on the belt, while it is moving, removing material if it's not PET or aluminum. Employees do sweeping on the belt, where they're riding the belt; sweeping material onto the belt. It's done every day we drop that material. I've seen it being done a few times. The only time employees would be loading the conveyor by hand would be when we're finishing up a material; employees are sweeping material onto the belt with a broom. - I didn't see the loader anywhere in the area when I got down there. I don't remember seeing [redacted]. I called him over when the Fire Dept. asked what happened. I am familiar with our compliance program ~~which is put together by Adrian (Levy)~~. Since the accident happened, we still operate around the belt in the same manner. We put grip tape down on the steel; it wears away in probably a month or a half. Employees are required to wear ankle high work boots. They are not required to have slip-resistant shoes.
